It must be demonstrated that the portion of public road rights-of-way, alleyway, or other public lands sought to be vacated, abandoned, and closed, is no longer needed to fulfill a public purpose.

Such vacation shall not become effective until a certified copy of an adopted Resolution by the governing body has been filed in the offices of the circuit court clerk and duly recorded in the public records of said county. (Ref: Section 177.101 Vacation and annulment of plats subdividing land, of Florida Statutes)

WHEREFORE, the undersigned petitions this Council to call a public hearing at Petitioner's expense to determine the viability of closing said street(s), road(s) alleyway(s) and that, upon such a hearing, this Council will determine that the same should be closed and adopt an appropriate Resolution closing, vacating, abandoning and discontinuing the same, and renouncing and disclaiming any right of the City of Crystal River and the public in and to any land delineated on the recorded plat of said, except for the reservation of the right to any easements as may be found necessary, by the City Council, to further and/or preserve the public health, safety, and welfare.
